









“ The WTA believes it is entirely feasible to ensure timely access to care for all Canadians that is comparable to that which is available to citizens in other countries. Waits would be measured in days or weeks rather than months and years. This progress would be achieved as part of a wider range of efforts to improve the overall quality of Canada's health care system. ”

WTA calls for same-day access. 	 Target: Citizens can access the most appropriate member of their primary care team within 48 HOURS.
ACCESS TO EMERGENCY DEPARTMENT (ED) CARE	NO NATIONAL GOVERNMENT ED TARGET HAS BEEN ADOPTED. <ul style="list-style-type: none"> See the 2014 report card for WTA ED targets. 	Target: Over 90% of patients are seen within four hours in the emergency department (i.e., admitted, transferred or discharged).  HRS MINS SECS
